HOW CAN YOU HELP

If you're looking for a new way to give back to your community and support Not Far From The Tree, consider planning a 3rd Party Fundraising event!

WHAT IS THIRD PARTY FUNDRAISING?

Unlike traditional fundraising events which are organized and hosted by the charity organization, third-party fundraisers are planned and executed by volunteer individuals, businesses, or community groups who are passionate about supporting a non-profit.



Why host a third party fundraising event?

- You'd like additional ways to get involved
- Your community is looking for ways to protect food security
- To celebrate or honour a member of your community

Third party fundraising events can be hosted in-person or virtually. Some common examples of third-party fundraisers include:

- Challenge events like runs, walks, or sporting events
 - You can ask people to donate to your cause, or set up a team and ask for a minimum fundraising amount. Other creative challenge ideas can be biking to work or school for a month, or a local food challenge
- Community events like bake sales, craft sales, car washes, art exhibitions, talent shows, and more
 - These events fundraise for a good cause while bringing your community together for a fun time
- Personal milestones like birthdays, anniversaries, weddings, graduations or other special occasions
 - Instead of asking for gifts, ask loved ones to make a donation in your name

WHAT KIND OF EVENTS CAN I **HOST**?

Third party fundraising events can be hosted in-person or virtually. Some common examples of third-party fundraisers include con't:

- Memorials or tributes
 - To celebrate or honour a loved one, you can create a fundraising page or host an event to support their passion for local food and our urban orchard
- Holidays
 - Seasonal or religious holidays are a popular time to reflect on our privileges and be grateful. Take this opportunity to encouraging giving back to non profits
- Corporate or school events
 - Engage students, teachers, coworkers, or employees to give back to our community. Any of the ideas for third party fundraising can be applied in a corporate or educational setting and provide the opportunity for fun and to educate people about our cause.

- Access to donor or member contact information.
- Fund or reimburse any expenses incurred throughout the planning and execution of the event or apply for any licenses for your event.
- If the event is cancelled, the event organizer agrees to contact the NFFTT at least one day prior to the event
- NFFTT cannot assume legal or financial liability for third-party events
- NFFTT is not responsible for any damage or accidents to persons or property

HOW TO COLLECT FUNDING

ONLINE FUNDRAISING

Set-up a fundraising webpage through CanadaHelps! This is an easy and flexible way to collect funds remotely from your donors.

IN-PERSON COLLECTION

Collect cash or cheques (made to MakeWay Charitable Society – Not Far From The Tree) to be remitted to NFFTT. Remember to track the name and email of each donor.

What is NFFTT?

We're Toronto's fruit-picking and sharing project. Did you know Toronto is home to a massive urban orchard? Over 1.5 million pounds of fruit grows right here in the city every year. We work to connect generous tree registrants with excess fruit to volunteers in their community who are willing to pick and share it. No good fruit should fall to waste when so many people can use it!

Why do you need my help?




Who is Makeway Charitable Society?

Are the funds I raise tax deductible?

Any funds over \$10 will receive a tax receipt!

However, sponsorships are not eligible for charitable tax receipts, as the sponsor receives advertising, marketing or promotional value and therefore the payment is not a gift. Instead, sponsors can receive a business acknowledgement letter for the value of their sponsorship which can be used to support business expenses. Gifts of artwork, wine, collectables, or items of a unique nature must be accompanied by a recent independent appraisal, regardless of value. Gifts of art donated by artists and art dealers are seen as dispositions from their inventory and therefore are not eligible for tax receipts.
